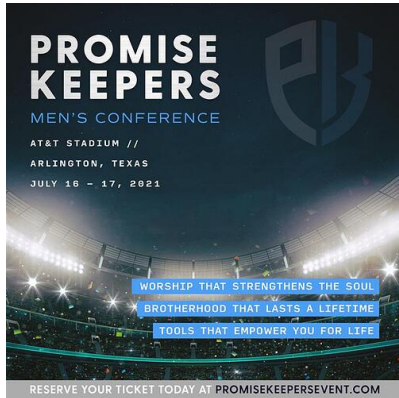
OneShare Health Highlights & Exciting Updates
