## New Smart Virtual Care and Dental Network are Live!

Effective August 1, 2021:

- A. Your Members now have access to a new and improved Telemedicine solution via **Clever Health™** (see below for a description & instructions).
- B. Your Members are now accessing the **Careington POS Dental** Network. Members should confirm their current dental Provider participates in the Network.

### Telemedicine Update:

**Clever Health™** Smart Virtual Care uses AI and population health data to help streamline and optimize your Member's virtual visit. Clever Health™ adds greater convenience for OneShare Members, faster visit times, more accurate diagnoses, additional prescription discounts, and 24/7 access to mental health chat resources.

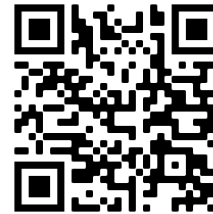
To do this we **highly encourage** Members to download the Clever Health™ App on their smartphone. This is crucial to getting the most out of their Smart Virtual Care, mental health resources, and RX discounts – it's important to note that the Clever Health™ App does not work on a desktop or computer.

**Members will receive instructions in their Newsletter on how to download, but please see below:**

**Access Smart Virtual Care via Clever Health™ by downloading the Clever Health™ App by either:**

1. Scanning the QR code below using the camera on your mobile phone:

*Note: You do not need to take a picture of the QR code, simply tap the screen to focus on the QR code. The active link will then appear. Click on the link to be taken to download the Clever Health™ App.*



2. Clicking on this link using your mobile phone

*Note: You can NOT download the Clever Health™ App on your desktop or laptop computer.*

3. Going directly to the app or Google Play Store, searching Clever Health™, downloading the app, and entering **Group Number 8101 Member Number 1000** when prompted.

4. Clever Health™ Smart Virtual Care (Telemedicine) is also available to Members without access to a smartphone by calling [\(833\) 387-9603](tel:8333879603). Members will follow the prompts to be sent a text message or continue to speak with a care coordinator.

**Careington POS Dental Network**

**Below are the steps for Members to Access Dental Discounts:**

**Step 1:** To locate a participating Provider, Members may call [\(833\) 387-9604](tel:8333879604) or go online to access the online Provider search <https://osh.solutionssimplified.com>.

**Step 2:** When scheduling an appointment, Members should inform the participating Provider's office that they are Members of the Careington Dental Network.

**Step 3:** Members present their Careington ID card upon arrival to receive savings.

**Step 4:** The Provider will collect payment at the time of service. Members are responsible for paying the total bill, less the applicable savings, when service is provided.

Changes will go live Sunday, August 1<sup>st</sup>, 2021. These changes will not affect Members in Massachusetts. MA Members will still utilize their existing Telemedicine and Dental Discounts.

New Member ID cards began mailing out starting July 23<sup>rd</sup>. Starting August 1<sup>st</sup>, Members will also be able to access their ID cards within their OneSource Member Portal by logging in at [OneShareMembers.com](https://OneShareMembers.com).
